SCHOOL BOARD MEMBERS CONFRONT SUOZZI

Months after his Commission's push for a cap on school property taxes, County Executive Suozzi had his first meeting with those who are elected to safeguard the fiscal and educational integrity of their community's schools – school board trustees.

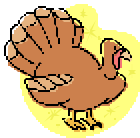
A special session at the NYSSBA Convention provided the sole opportunity for board members to directly question Mr. Suozzi's understanding of the grassroots consequences of his tax cap campaign. In short order, he acknowledged to NYSSBA moderator Marc Humbert that the state is unable to fund any revenue shortfalls created by the cap or take over the cost of mandates. The resulting school budget chaos would, Mr. Suozzi asserted, "prompt board members, administrators and parents to force state legislators to relieve districts of some costly mandates (Wicks Law and Triborough) that tie your hands." This remained the sole defense of his school tax cap plan throughout the session.

The Commission may be unable to meet its December 1st reporting deadline on curtailing special education costs and could seek an extension. Mr. Suozzi said he wanted to learn more about the impact of payments to private and parochial schools on a per pupil costs.
