# Offshore Wind Energy & Manufacturing Industry Expo Event a Success!



Over 220 people gathered on 11/9/22 at the Cradle of Aviation to hear about the new Offshore Wind Energy industry coming to Long Island and also got reacquainted with a long existing industry in our region in manufacturing. In the future the Offshore Wind Energy industry will create over 10,000 jobs in our region and they are looking towards public education to partner and collaborate to raise awareness and help with future workforce development needs. Farmingdale State University presented to the attendees the higher education programs already in place to help with workforce development as well.

The manufacturing industry was well represented. On Long Island there are over 3,000 employers and over 72,000 jobs in manufacturing with an average salary of \$82,000 a year. U.S. Navy Master Chief Josh Sturgill explained to those in attendance the on-going critical role Long Island manufacturers play in defense contracting of high quality parts for the Naval submarine fleet as an example of the importance of manufacturing in our region. The feedback after the event from educators was impressive and that the event had a lot of meaningful information shared and great opportunities to network with industry professionals to create unique opportunities for our students. Special thanks to our corporate sponsors of the event, Attentive Energy, Community Offshore Wind, Haugland Group, and Sunrise Wind.

The speaker portion of the program finished with a high school senior from West Islip High School, Robert Mineo, who reminded the audience about the importance of partnerships with business and schools which enabled him to have an internship at local manufacturer which has now set him on a path to become an engineer after graduation.

Uniondale students, staff and board members presented a workshop on Facilitating Authentic Student Voice (Walk it Like You Talk it: Creating Authentic Spaces for Student Voice) at the CUBE conference on Friday, December 9, 2022 in Miami, Florida.

Board trustee, Adelina Blanco-Harvey, Stacie Reid, Director of Guidance, Keith Coles, Social Worker at Lawrence Road Middle School and two Uniondale High School students; Edward Genao and Justin Holness, joined superintendent Dr. Monique Darrisaw-Akil in discussing the ways the school district is working to empower students, promote self-efficacy and create opportunities for leadership.

Trustee Blanco-Harvey discussed the Board's commitment to having a student board member as well as other ways the Board involves students in decision-making. Superintendent Darrisaw-Akil talked about the underlying beliefs around student voice and the importance of empowering students from historically marginalized groups. Ms. Reid and Mr. Coles illustrated the numerous initiatives at both the building level and the district level to involve students and the two students each shared their personal experiences as student leaders. The presenters ended the session by asking each attendee to make a commitment to increasing student voice in their districts.

# N-SSBA's Executive Director Robert Vecchio Appointed to LIPA Advisory Committee

Assemblyman Fred Thiele recommended N-SSBA's Executive Director to be appointed to the LIPA Advisory Committee which will to report the Legislative LIPA Commission which Mr. Thiele co-chairs along with Senator Kevin Thomas

The LIPA Commission is a bipartisan legislative commission which is exploring all options on how best to structure LIPA going forward.

LIPA is currently set up as a hybrid public/private power authority. LIPA sub-contracts out the servicing and management of the grid to PSE&G Long Island.

Assemblyman Thiele said this arrangement is the only one of its kind in the country, and he believes should be operated differently to enable cost savings to ratepayers and have better management for service delivery and a better storm recovery response.

The Advisory Committee will be exploring all options going forward and will make recommendations to the Commission in a report by April 2024.

Mr. Vecchio stated he was honored to be asked to serve and is concerned about PILOT payments currently paid to schools across Long Island and what will happen to them if LIPA becomes a fully public power authority along with costs for service going forward as school districts are large customers as well.

The other concerns mentioned during the first meeting of the LIPA Advisory Committee were the long term debt and what the governance structure of LIPA going forward should be and how best to make sure there is accountability locally going forward

# From the N-SSBA Archives N-SSBA's Semi-Annual Dinner Meeting Amityville Junior High School December 18, 1969

3. Taylor Law

Mrs. Anita Messinger, Chairman, submitted copies of the Taylor Law Committee survey, a copy of which is attached to the minutes of this meeting.

#### New Business

- 1. Dr. David Guerin, President of the Long Island Educational Communications Council, addressed the membership. He stated his concern over the fact that so many school budgets are being defeated and that his organization is interested in reaching the public by setting up an exhibit at Roosevelt Field on March 19, 20, and 21, 1970 to demonstrate to the public what quality education is through the use of films of students at work and by distributing brochures. He asked for the endorsement of Nassau-Suffolk School Boards Association.
- Mr. Nissenoff, of Long Beach School Board, spoke to the membership concerning
  the State taxes being imposed on districts which are in the process building
  schools. He urged members who are interested in abolishing the section of the
  tax law which requires school districts to pay this tax to contact him at
  Long Beach.
- 3. A copy of the Great Neck Resolution concerning opposition to the use of public funds for parochial and private schools was distributed. It was stated that in order to consider this matter an affirmative vote of 2/3 of the districts present on suspension of the by-laws was required, whereupon a motion from the floor was made and seconded but failed to carry the 2/3 affirmative votes. There were 29 affirmative votes, 13 opposing and 3 abstentions cast.

#### General Discussion

I. Mr. Kafka, President of NYSTA, addressed the membership. He said that teachers wish to have a part of the growth of the economy. He said that teachers are very much concerned about maintaining sound educational programs and will not stand by and watch cuts in the educational program to save money. He mentioned that teachers also wish changes in the Taylor Law to provide equality at the negotiating table - to bring about a grievance with no unilateral action on any one group. He reaffirmed that teachers, also, believe in equal educational opportunity. He further declared that teachers want a voice and involvement in the decision making process in order to bring about improvement in education. He agreed that there are a few incompetent teachers who should not be teaching. He stated that teachers have to be involved in setting standards in licensing and providing removal of licenses from those who are not able. He noted that teachers are willing to accept the responsibility but want a sharing of the power. Mr. Kafka declared that only the Board of Education has the power to grant tenure and remove a teacher and that it is truly possible to remove a tenure teacher from his position.
